



Warminster Sideroad Drainage Improvements Municipal Class Environmental Assessment Notice of Study Completion

The Township of Oro-Medonte has completed a Drainage Improvement Study following schedule B of the Municipal Class Environmental Assessment Process (Phases 1 & 2) to identify the existing drainage deficiencies and develop drainage solutions to address the deficiencies, reduce flooding, resolve public safety concerns and improve maintenance opportunities through a section of Warminster Sideroad.

One (1) Public Information Center (PIC) was held where the public and interested stakeholders could provide comment on the project details and the various physical, natural, social, cultural and economic impacts. In addition, property owners who would be directly impacted by the proposed drainage improvement solutions were directly consulted. No public or agency comments were received to date. An Environmental Study Report (ESR) has been prepared that documents the study process and presents the Preferred Solution. By this notice, the Warminster Sideroad Drainage Improvements ESR is available for public review starting June 3, 2024 at the following locations:
