### Minor Variance Application Notice of Public Hearing

**Purpose:** Consent Application B20/86 was granted in 1986 to permit the creation of a new lot. Parts 1 & 2 of Plan 51R15844 were intended to be registered as a new lot; however, the registration only included Part 1, resulting in the severed lot being landlocked. The applicants have submitted Consent Application 2024-B-06 to permit a boundary adjustment to sever Part 2 of Plan 51R15844 from 261 Penetanguishene Road and merge it with 245 Penetanguishene Road. The proposed residential lot configuration is deficient in lot area and lot frontage; therefore, the applicants are seeking relief to the following sections of Zoning By-law 97-95:
